Payment must be paid in full before shipment of any puppy. Buyer will pay all shipping and miscellaneous expenses associated with the transport of puppy.

Payments by check must be received 10 days prior to pick up or shipping of dog/puppy.

WARRANTIES FOR PURPOSE

This puppy is sold as a pet quality puppy only. Puppy is warranted only for the purpose of being a companion animal. While it may be capable of showing or performing other function, no warranty is given as to its fitness for any special purpose.

Buyer acknowledges the following conditions specifically by initials:

*Hereinafter referred to as "Puppy" sold to Buyer by Seller as "Pet Quality". _____ (initial)

*Not warranted for any breeding or exhibition. _____ (initial)

*The kennel prefix "Rhyse's" must be used as the first word of the registered name. _____ (initial)

*Application for registration to American Stock Dog Registration (ASDR) will be given at the time a spay/neuter letter is received from a veterinarian. _____ (initial)

HEALTH GUARANTEE

Seller guarantees puppy is sound and free of disease (with the exclusion of treatable intestinal parasites) at time of transfer of said dog/puppy to buyer for a period of three days if Buyer meets these conditions:

Buyer agrees to have purchased puppy examined by a licensed small animal veterinarian within three days receipt of puppy. The health guarantee is void if Buyer neglects to have a veterinarian examine the puppy/dog within the three-day period. If the puppy is found to be in poor health during this time Buyer will have the option to return the puppy for a full refund. Before any refund, Seller has the right to request a second opinion about the health of the Puppy from a non-associated veterinarian.

Should Buyer disregard the Health Guarantee conditions and decide to keep the dog/puppy Buyer renders the Health Guarantee void, and Buyer assumes all expenses involved with said dog/puppy.

Remedies: Seller will replace (of equal value) or refund purchase price if Buyer:
Provides a signed statement from the two licensed examining veterinarians stating.

- Failure to pass a the first veterinary exam within the three-day post purchase exam, and the second opinion veterinary exam. _____ (initial)

Buyer acknowledges the following conditions specifically by initials:

*At no time will the seller be responsible or obligated to pay for veterinary care. _____ (initial)

* Under no condition and at no time during the life of the dog/puppy will SELLER pay or assist in paying veterinary expenses after the animal is purchased. _____ (initial)

* Under no condition and at no time during the life of the dog/puppy will SELLER pay or assist in paying expenses related directly or indirectly to any inheritable/genetic defects. _____ (initial)

* Seller guarantees that puppy has received all recommended vaccines and de-worming, and will provide health records to buyer.

BREEDING RIGHTS:

*Breeding rights are /are not (circle one) hereby sold for an additional fee. _____ (initial)

* Violation of this agreement: Buyer agrees to pay an additional \$10,000 for any Breeding Rights Violation. A Breeding Rights Violation occurs if Buyer uses Puppy for breeding purposes without purchasing breeding rights from Seller in this or another agreement. _____ (initial)

PRACTICAL ADVISE

Seller recommends that no IVERMECTIN product be used.

Seller recommends not to allow puppy to jump over 1 foot before 12 months of age, as this can create skeletal problems.

GENERAL

SELLER RESERVES THE RIGHT TO REFUSE THE SALE OF ANY PUPPY.

Seller has the right to stop breeding at any time.

Seller shall not be held responsible for the development of disqualifying faults, diseases, viruses or disorders, which are due to the buyers neglect.

This contract is not transferable. This purchase is non-refundable. If the puppy needs to come back to the breeder after it has passed it's 3 day past delivery examination, there will be no refund.

This agreement will be governed by the laws of the State of Georgia and if either party is forced to take legal action to enforce any part of this contract, action shall be initiated in the county of the SELLERs residence only.

This contract may not be altered, modified or rescinded unless agreed in writing by both Buyer and Seller.
